GRENADA AFTERMATH: IT IS ALMOST A YEAR SINCE THE U.S. ACTION IN GRENADA AND THE SOLDIERS HAVE BEEN THERE ALMOST A YEAR. IN LESS THAN A YEAR THE OVERSIZED AIRPORT THE CUBANS WERE BUILDING IS BEING FINISHED BY THE AMERICANS. THE DOCK WHERE SO MANY RUSSIAN GUNS WERE OFFLOADED BY NIGHT IS NOW RECEIVING AMERICAN ARMS. A: I HAVE SAID THAT I AM GUARANTEEING THEIR SECURITY WITH MY LIFE. I'LL BE THERE WITHOUT ARMS EITHER. SO, WHATEVER WILL HAPPEN IT WILL BE MY LIFE FIRST.
