1. (S) SUMMARY. ON APRIL 3, LABOFF VISITED NATIONAL POLICE (PN) DIRECTOR COL. REYNALDO LOPEZ NUILA TO INQUIRE ABOUT THE HARCH 27 ARREST OF CARLOS ERNESTO VASQUEZ SONETA, THE SECRETARY GENERAL OF THE MATERS AUTHORITY WORKERS UNION (SETA). THE TEXT OF A PN

DOCUMENT PURPORTING TO BE VASQUEZ'S VOLUNTARY TESTINONY

IS REPORTED WITHIN THE BODY OF THIS CABLE. IT IS, SUPPOSEDLY, VASQUEZ'S RELATION OF HIS CAREER WITHIN THE FEDERATION OF SALVADORAN WORKERS (FENASTRAS) AND OF HIS PAST AND PRESENT ACTIVITIES AS A MEMBER OF THE FARM GUERRILLA GROUP.

2. (S) LABOFF MET ON APRIL 3 WITH THE DIRECTOR OF THE NATIONAL POLICE, COL. REYNALDO LOPEZ MUILA, TO INQUIRE ABOUT THE MARCH 27 ARREST OF CARLOS ERNESTO YASQUEZ, THE SECRETARY GENERAL OF SETA, THE UNION OF EMPLOYEES OF ANDA, THE MATERS AUTHORITY. LOPEZ MUILA SHOWED LABOFF AM ENTRY IN THE PN'S ARREST LOGGOOK MOTING YASQUEZ'S DETENTION FOR SUSPICION OF BEING A MEMBER OF THE FARN GUERRILLA GROUP. LOPEZ MUILA ALSO GAVE LABOFF A COPY OF A DOCUMENT ISSUED BY THE PN'S CRIMINAL INVESTIGATIONS UNIT (CIC), MIICH DOCUMENT IS, PURPORTEDLY, YASQUEZ'S DETAILED AND UNFORCED CONFESSION RELATING SUBVERSIVE ACTIVITIES AND CONTACTS WITHIN THE FARM. THERE FOLLOWS AN ABRIDGED TRANSLATION OF THIS DOCUMENT:

3. (U) BEGIN TEXT. CARLOS ERNESTO VASQUEZ SOMETA SAID HE HAS BEEN A MEMBER OF THE FARM TERRORIST ORGANIZATION SINCE DECEMBER, 1960. HE IS PRESENTLY THE SECRETARY GENERAL OF THE WATERS AUTHORITY WORKERS UNION (SETA) AND THE SECRETARY OF ORGANIZATION OF THE MATIONAL FEDERATION OF SALVADORAN WORKERS (FEMASTRAS). VASQUEZ FURTHER STATED THAT HE HAS FUNCTIONED BOTH AS A LABOR AND POLITICAL ACTIVIST WITHIN SETA, FEMASTRAS AND THE FARM, HE STATED THAT HIS MISSION IS TO INDOCTRINATE AND ORIENT THE SETA RANK AND FILE ON THE SOCIAL, POLITICAL AND ECONOMIC GOALS OF THE FARM'S PLAMS, WHICH INCLUDE THE EVENTUAL IMPLEMENTATION OF A

PROVISIONAL FILM GOVERNMENT IN EL SALVADOR.

4. (U) VASQUEZ INFORMED THAT HE BEGAN TO HORK FOR ANDA IN 1978. AND ALSO JOINED SETA AT THAT TIME. IN OCTOBER, 1979, HE HET MARIO CABRERA, CODE NAME "BRIGIDO," A PROMINENT FARN LEADER (NOTE: CABRERA IS THE SECRETARY GENERAL OF FENASTRAS). ONCE HE JOINED THE FARN, VASQUEZ WAS CHOSEN TO REPRESENT FENASTRAS IN SEVERAL INTERNATIONAL EVENTS, INCLUDING RED "SUMMIT" MEETINGS IN HAVANA AND PRASUE.

5. (U) YASQUEZ FURTHER INFORMED THAT A FELLOW MEMBER OF SETA, FRANCISCO ANTONIO ROMERO MARTINEZ, HAS LIMKS WITH THE CAYETANO CARPIO REVOLUTIONARY WORKERS' MOVEMENT (NOR), A HARD-LINE SPLINTER GROUP OF THE FPL GUERRILLA ORGANIZATION. THIS SAME ROMERO RECENTLY URGED SERILLA ORGANIZATION. THIS SAME ROMERO RECENTLY URGED SETALE SOF THE 9 FSR MEMBERS ARRESTED BY THE NATIONAL POLICE ON JANUARY 18, 1983 (SEE REFTEL B). ANOTHER SETA MEMBER, CIRILO HUEZO, A MIDDLE ECHELON MEMBER OF THE FARM, IS THE FENASTRAS LABOR/POLITICAL ADVISOR TO THE SETA WORKERS. HUEZO IS ALSO FENASTRAS' SECRETARY OF LABOR DISPUTES.

7. (U) VASQUEZ DECLARED THAT FENASTRAS RECEIVES FUNDS FROM THE MOSCOM-DOMINATED WORLD FEDERATION OF TRADE UNIONS (WFTU) AND FROM THE FOR. THESE FUNDS ARE SENT FROM MEXICO THROUGH A MEMBER OF THE PCES WHO SERVES AS A COURIER, ONE JORGE MEMOZA, MEMDOZA IS ALSO A MEMBER OF THE FUSS, THE PCES' LABOR FROMT IN EL SALVADOR. VASQUEZ GAVE THE CODE NAMES (ROLANDO, SOFIA AND MICHELLE) OF MEMBERS OF THE MON-GOES MUMAN RIGHTS COMMISSION WHO MAYE ACTIVE LINKS TO THE FARM, VASQUEZ
