1. THE PRO-FMLN LABOR GROUP FENASTRAS ALLEGED OCTOBER 26 THAT 10 MEMBERS OF THE CHAN CHAN FAMILY HAD BEEN DETAINED IN SANTA ANA BY ELEMENTS OF THE SECOND BRIGAGE IN AN EFFORT TO FORCE MARIA JUANA ANTONIA MEDINA, MOTHER OF MISSING FENASTRAS EMPLOYEE SARA CHAN CHAN, TO TURN HERSELF OVER TO AUTHORITIES. ACCORDING TO FENASTRAS (AND NUMEROUS US CIT CALLERS WHO APPARENTLY RECEIVED A FENASTRAS TELEFAX ON THE SUBJECT), THE DETENTIONS TOOK PLAGE AT MIDNIGHT, OCTOBER 26.

2. POLOFF WAS SCHEDULED TO MEET WITH ONE OF THE ALLEGED DETAINEES, GERTRUDE MEDINA, 67, ON SATURDAY, DCTOBER 28. HOWEVER, MARIA JUANA ANTONIA MEDINA ATTENDED THE MEETING IN HER MOTHER'S PLACE. MARIA, WHO WAS IN SAN SALVADOR AT THE TIME OF THE DETENTIONS, STATED THAT AS FEW AS 5, AND AS MANY AS 9 MEMBERS OF HER FAMILY MAY HAVE BEEN DETAINED (NOT 10, AS FENASTRAS ORIGINALLY REPORTED). THEY WERE ALL RELEASED, SHE STATED, BY 10 A.M. THE FOLLOWING DAY.

HER BROTHER, EVIL DE JESUS MEDINA, WAS TOLD TO PRESENT HIMSELF EVERY WEEK TO SECOND BRIGADE AUTHORITIES UNTIL MARIA TURNED HERSELF IN, SHE ALLEGED. NO ONE NOTED ANY NAMES OF ANY OF THE CAPTORS, NOR DID THEY SEE ANY ARREST WARRANTS.
